a. <u>Treasurer's Report:</u> Finance Committee met with Hollie Pladson. Reviewed the services that will be provided and are gathering costs from her for the services needed. The Finance Committee did conclude that we will need to file 2015 taxes based on the fees collected for 2015. An extension has been filed at this time.

<u>Approve the Annual Budget:</u> The Board is expecting to collect \$554,000.00 in Annual Revenue for 2016. The board has suggested we allocate the funding toward the following services:

70% Sales and Marketing =\$382,901

10% Zone Marketing= \$54,700

15% Administration=\$82.050

2% Collection Fees=\$16,410

3% Contingency=\$ 10,940

We currently have approximately twelve target agencies we are expecting to bid on the RFP. Four of the twelve agencies are local to Butte County.
- **e.)** Review and Consideration of preliminary design for State Fair County Exhibit: We will be reviewing Debra Lucero's plan for the Tourism Exhibit.
- **f.)** <u>Discussion:</u> Explore Butte County is considering becoming a member of California Travel Association. This item has been moved for further discussion at our June meeting.
